# RSCF 195

The Nuova Simonelli PS195 hardness reduction cartridge helps to provide consistent high quality water for espresso and espresso based drinks at flow rates up to 1.0 gpm (3.7 lpm) . A strong-acid ion-exchange resin reduces calcium and magnesium ions to help prevent hard scale formation on boilers. Hard scale can result in energy inefficiency, equipment downtime and expensive service calls. Premium activated carbon reduces chlorine taste and odor as well as bitterness associated with poor water quality.

The Nuova valved head allows for sanitary, quick and easy cartridge change outs. Simply turn the cartridge a ¼ of a turn to shut off the incoming water and disengage the old cartridge.

- Consistent, great tasting espresso and espresso drinks from water with reduced hardness and chlorine taste and odor.
- Reduced hard scale formation on the heating coils by the reduction of calcium and magnesium ions results in improved energy efficiency and reduced downtime and expensive service calls.

- 3/8" FNPT horizontal inlet and outlet ports allow direct or easily adaptable connections to existing plumbing lines.
- Sanitary Quick Change (SQC) encapsulated cartridges reduce contamination during change-outs.



- Protect from freezing, remove filter cartridge when temperatures are expected to drop below 40°F (4.4°C).
- Do not install on hot water supply lines. The maximum operating water temperature
  of this filter system is 100°F (37.8°C).
- Do not install if water pressure exceeds 125 psi (862 kPa). If your water pressure exceeds 80 psi (552 kPa), you must install a pressure limiting valve. Contact a plumbing professional if you are uncertain how to check your water pressure.
- Do not install where water hammer conditions may occur. If water hammer conditions
  exist you must install a water hammer arrester. Contact a plumbing professional if you are
  uncertain how to check for this condition.
- The disposable filter cartridge MUST be replaced every 12 months, at the rated capacity
  or if a noticeable reduction in flow rate occurs.
